1. This agreement may not be altered by either HOST or SPONSOR when full Payment is made.
2. HOST shall be responsible for all cost of entertainment presentation and venue, with no responsibility of further cost from SPONSOR.
3. HOST shall provide adequate security, fencing, and restrooms.
4. This agreement shall be governed under the laws of the County of Rock Island, State of Illinois. It is also agreed upon that the SPONSOR shall hold the HOST harmless of any claims or legal action between SPONSOR and costumers of SPONSOR. This agreement shall not be altered or changed in any way, unless an instrument in writing signed by both parties.
5. HOST is responsible for providing insurance for event. The policy provided by HOST shall not hold SPONSOR responsible in any way for damage of property and/or injury at event from time of set-up to take-down.
6. In the event of prevention of event do to something outside the control of SPONSOR/HOST, it is understood and agreed that there shall be no claim for damages to this agreement, and obligations from either party shall be deemed waived.
7. If HOST breeches this agreement, they will be held to providing funds acquired back to SPONSOR.
8. Whomever signs this agreement must be of legal age, and must be authorized representative, employee, owner, and/or officer of SPONSOR.
9. SPONSOR is able to have a both/table at event and keep (100%) of all profits from their sales. Items being sold cannot compete with event host.
