1. This agreement may be canceled by either party with a written notice of cancellation of sixty (60) days prior to engagement date. Notification of cancellation to be given at the address listed in upper right hand corner of document.
2. HOST shall be responsible for all cost of entertainment presentation with no responsibility on ARTIST behalf.
3. HOST shall provide adequate security for the protection of ARTIST's equipment along with the safety of ARTISTS.
4. This agreement shall be governed under the laws of the county of Rock Island, State of Illinois. It is also agreed upon that the ARTIST shall hold the HOST harmless of any claims or legal action between ARTIST and costumers of ARTIST. This agreement shall not be altered or changed in any way, unless an instrument in writing signed by both parties.
5. HOST is responsible for providing insurance for event and ARTIST. The policy provided by HOST shall not hold ARTIST responsible in any way for damage of property and/or injury at event from time of set-up to take-down.
6. In the event of prevention of event do to something outside the control of ARTIST/HOST, it is understood and agreed that there shall be no claim for damages to this agreement, and obligations from either party shall be deemed waived.
7. If ARTIST breeches this agreement to their performance, they will be held accountable for marketing funds and/or option of another ARTIST for event.
8. Whomever signs this agreement must be legal age, and must be authorized representative, employee, owner, and/or officer of ARTIST.
9. ARTIST is able to have a booth/table at event and keep (100%) of all profits from their sales.
